RESOLUTION NO. 2023-13

**A RESOLUTION OF THE BOARD OF DIRECTORS
OF THE CYPRESS FIRE PROTECTIN DISTRICT PROCLAIMING A LOCAL
EMERGENCY, RATIFYING THE STATE OF EMERGENCY PROCLAIMED ON
MARCH 4, 2020, AND AUTHORIZING REMOTE TELECONFERENCE
MEETINGS OF ALL DISTRICT LEGISLATIVE BODIES FOR THE FOLLOWING
30 DAYS IN ACCORD WITH THE RALPH M. BROWN ACT**

FACTS

1. The Cypress Fire Protection District (District) is public entity established under the laws of the State of California.
2. The District is committed to preserving and nurturing public access and participation in meetings of the District Board and Committees; and
3. All meetings of District legislative bodies are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 – 54963), so that any member of the public may attend, participate, and observe District legislative bodies conduct business; and
4. The Brown Act, Government Code section 54953(e), enables remote teleconferencing participation in meetings by members of a legislative body, without strict compliance with requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and
5. One required condition is that a state of emergency has been declared by the Governor of the State of California pursuant to Government Code section 8625, proclaiming existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and
6. A proclamation is made that there is an actual incident, threat of disaster, or extreme peril to the safety of persons and property within the District’s jurisdiction, caused by natural, technological, or human-caused disasters; and
7. State or local officials have imposed or recommended measures to promote social distancing, or, that having the legislative body meet in person would present imminent risks to the health and safety of attendees; and

8. The District Board affirms these conditions now exist in the District. Specifically, on March 4, 2020, the Governor proclaimed a State of Emergency to exist as a result of the threat of COVID-19. That Proclamation has not been terminated by either the Governor or the Legislature pursuant to Government Code section 8629; and
9. Despite sustained efforts to remedy this circumstance, the District Board determines that meeting in person poses an imminent risk to health and safety of attendees due to the COVID-19 virus and its variants; and
10. The District Board finds the emergency created by the COVID-19 virus and its variants has caused, and will continue to cause, conditions of peril to the safety of persons within the District that are likely to be beyond the control of services, personnel, equipment, and facilities of the District, and desires to proclaim a local emergency and ratify the proclamation of state of emergency by the Governor and similar local health orders that require social distancing; and
11. As a consequence of the local emergency, the District Board determines that all legislative bodies of the District are required to conduct their meetings without full compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that those District legislative bodies shall comply with the requirements to provide public access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and
12. Each District legislative body shall continue to conduct meetings with public access available via call-in or internet-based service options and the public shall be allowed to address the legislative body directly in real time; and
13. This Resolution shall authorize the Fire Chief to establish and maintain platforms necessary for each District legislative body to hold teleconference meetings and provide an avenue for real-time public comments for such meetings; and
14. The District Board finds the introduction and adoption of this resolution is not subject to the California Environmental Quality Act (CEQA) as the activity is not a project as defined in Section 15378) of the CEQA Guidelines.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF THE CYPRESS FIRE PROTECTION DISTRICT:

SECTION 1. RECITALS. The foregoing Findings are true and correct and are adopted by the District Board as though set forth in full.

SECTION 2. PROCLAMATION OF LOCAL EMERGENCY. The Board hereby proclaims that a local emergency now exists throughout the District, and meeting in person would present imminent risk as a result of the COVID-19 virus and its variants.

SECTION 3. RATIFICATION OF PROCLAMATION OF A STATE OF EMERGENCY. The Board hereby ratifies the Governor of the State of California's Proclamation of State of Emergency, effective as of its issuance date of March 4, 2020.

SECTION 4. REMOTE TELECONFERENCE MEETINGS. The Fire Chief and legislative bodies of the District are hereby authorized and directed to take all actions necessary to carry out the intent and purpose of this Resolution including, conducting open and public meetings in accordance with Government Code section 54953(e) and other applicable provisions of the Brown Act.

SECTION 5. EFFECTIVE DATE OF RESOLUTION. This Resolution shall take effect immediately upon its adoption and shall remain in effect for a period of 30 days, or until such time the District Board adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which District legislative bodies may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.



General Information:

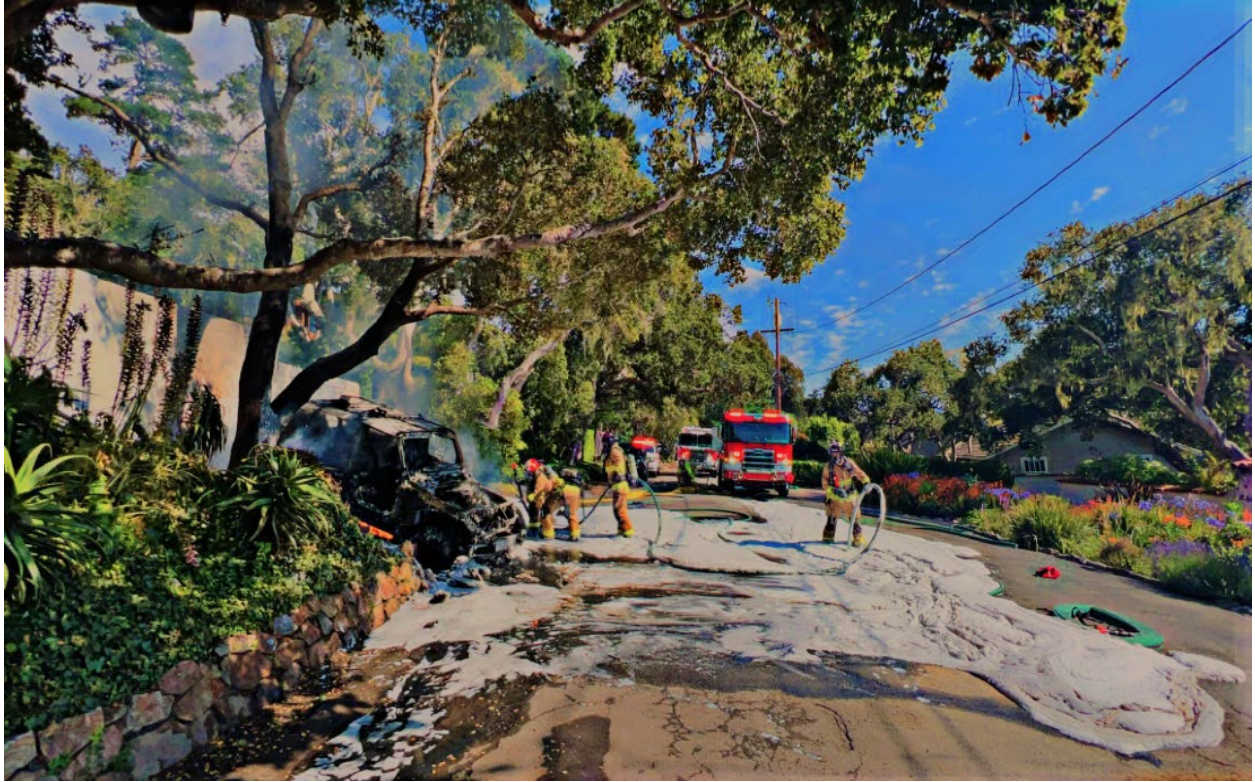
On July 27th, 2023, your firefighters from Cypress FPD responded to assist Carmel Highlands FPD with a vehicle accident on Hwy 1 near Sonoma Lane. Units arrived at scene and found a vehicle had crashed through a fence and rolled down a ravine with one person trapped inside. Crews had many difficult obstacles to overcome: making access down the ravine, victim extrication using several rescue tools, and then on top of all that, we had to set up a rope rescue system to aid in the extraction up to the roadway and into the ambulance. The patient sustained significant injuries, but due to the skills of your firefighters, from the paramedic level of care to the highly technical extrication, the victim was able to survive. Crews from Cypress Fire Protection District and Pebble Beach Fire Department assisted during the incident, including one of our UAS(drones) to help search the area for any more potential victims.



On August 20th, Firefighters from Cypress FPD responded to a reported vehicle fire threatening a structure at 24409 San Marcos in Carmel. Medic Engine 28 arrived and reported a passenger vehicle fully involved with fire and threatening trees and a structure. Due to the quick response, they were able to stop the fire from spreading to any vegetation or the structure. The vehicle was a total loss, and the cause of the fire is under investigation.

Fire Protection & Planning

General Information:

Your fire prevention team assisted with the 2023 Pebble Beach Concours D'Elegance which was held August 14-20th, 2023. The team assisted with fire/life safety inspections, crowd control management, logistical support, and Community Emergency Response Team (CERT) liaison. The event was a safe success, and we are all looking forward to the next one.

Battalion Chief Frank Espinoza represented the Cypress Fire Protection District and was assigned as a Public Information Officer (PIO) to the Rabbit incident in the Riverside Unit for six days. The incident was one of four ongoing incidents that was burning in the Riverside Unit and Chief Espinoza was utilized in the field to provide current information about the incident to the citizens, media, and firefighters on the line as well as gather information from the fire line. Information that a PIO provides consists of updated fire acreage and containment, locations of evacuation centers, areas of evacuation warnings/orders, road closures, and any threats to the community or infrastructure. A PIO also serves as a liaison to the media to safely guide them around an incident.

Public Education:

The smoke detector replacement program continues to be a hit throughout the district. The supply of smoke and carbon monoxide detectors have been replenished and your Fire Prevention Team is prepared to assist the community with replacement. The program has been advertised on the District's website and social media platforms. This reporting period seven smoke detectors have been replaced for residents.

Training:

Four Recreational Off Highway Vehicle (ROHV) classes have been held with over 27 personnel from the battalion completing the online safety class and a driving skills course at the Pebble Beach Company maintenance yard. Skills consisted of several cone evaluations, traversing slopes and rough terrain followed by a cross country drive through the fire roads. Upon completion of this training personnel are prepared to respond on our Rough Terrain Vehicles (RTVs) for emergency response including but not limited to lost/injured hikers and cyclists in remote locations, assist with rescue watercraft launch operations, drone supports, fuel reduction projects, and special events. The most recent event was the U.S. Women's Open of Golf where the RTVs were utilized for emergency response throughout the course.

Fuels:

Cypress Fire Protection District resources in cooperation with the CAL FIRE Resource Management team and the Pinnacles Fire Crew (CAL FIRE/California National Guard) have made tremendous progress on one of the predetermined priority fuel reduction projects which encompasses Pacific Meadows, Del Mesa Carmel, and Roach Canyon. Engine crews, hand crews and overhead personnel have used hand tools, chippers and two remote control masticators obtained by the CAL FIRE Resource Management team via the 2019 Governor's Early Action Plan Budget to re-open fire roads that were largely overgrown and reduce fuels around the Pacific Meadows Community. Crews heavily utilized the two masticators clearing the 5,000' long Martin Canyon Fire Road providing secondary access and egress for first responders. Work was also completed by masticating over 18 acres of overgrown fuels including non-native Genista that was over 6' tall. This fuel reduction work also provides a defensible barrier to this high-risk occupancy when considering sheltering in place versus evacuating under wildland fire conditions. Thank you to John Trenner, the Resource Management team, and the Board for all the continued support on this project!



Community chipping was conducted September 11-22, 2023. During this rotation the Prevention Team has included a door hangar that can be left with the resident which explains why a pile may not have been chipped.
